- A. International Travel from Covenas, Columbia to Santa Barbara, CA
- B. The final step in the process to synchronize the definitions and regulations of Service Disabled Veteran Owned Small Businesses
- C. A Statutory Requirement from the 2021 NDAA
- D. An opportunity to simplify and streamline the veteran verification/certification experience

Answer: All the above. We will only discuss B, C and D.

Change is achievable in multiple areas

I've Heard This Before, Will Anything Really Change?

- Reduced burden on all applicant companies for initial applications and recertifications
 - Remove or rewrite ambiguous questions
 - Smarter questions that align with machine intelligence to direct review of only relevant documentation parts
- Reciprocity with other SBA certification programs once and done
- Annual "Change" Questionnaire and Applicant Certification
 - For company Only need to review changed documents, ownership, organization, structure, taxes
 - For Individuals ownership share/interest; "outside employment" or changes affecting control or affiliation issues
- Risk managed due diligence. Is it necessary to always read every document in detail and do extensive internet research? Note: Much of the material retrieved from the internet is out of date and inconsistent requiring extra effort to sort through. Much of the business/governance documentation never (or rarely) changes.



How will these changes affect my application for certification?

- For documentation preparation, probably, not very much
 - Still a collection of normal business documents that you should already have
 - Basically same/similar documents, hopefully, fewer
- For Questions and Guidance, probably a lot
 - Will simplify and improve your experience



Is Certification a Business Guarantee?

- Only if you can deliver value
- Business planning, governance, strategy comes first
 - VIP Start know what's important
 - VIP Grow when you are ready for the next level
- Professional Certifications business and individual
- Small Business Certifications can help open doors, but it's not a "gimmee" or entitlement



What do I do? Preparation for Certification(Verification)

- Ownership, Control and Size
 - Owner/Member Demographics
 - SDVOSB 51% minimum Service Disabled Veteran
 - WOSB 51% minimum Women
 - HUBZone 51% US Citizens (also 35% of employees live in HUBZone)
 - 8(a) 51% Socially and Economically Disadvantaged
 - Meet Small Business Size Standards
 - Demonstrate Ownership and Control
- Documentation
 - Remember, governance comes first
 - Should be a collection of "normal" business governance and operating documentation



How to Write a Winning Proposal

- How did that get in here??
- Getting a certification/verification is like writing a winning proposal
 - A set of criteria you need to meet
 - A submission to a reviewing body
 - Success, denial, resubmission, etc.
- Your workload, timeline and success are based on your preparation and your understanding of your customer's requirement
 - By not doing these properly, I changed a 90 day process into a 10 month process



Some Quick Tips

- Your business documentation should be a collection of documents and/or reports, not a marathon document creation exercise
- Veteran/Service Disabled Veteran Status via DD-214, VA Disability Letter, Service Disability Letter
- Lots of help available from SBA, Procurement Technical Assistance Centers (PTACs), Veteran Business Outreach Centers (VBOCs), Veteran Service Organizations (VSOs), Veteran Organizations (e.g. NVSBC) and Veterans

- Review the proposed 13 CFR 128 <u>Federal Register ::</u> Veteran-Owned Small Business and Service-Disabled, Veteran-Owned Small Business-Certification.
- Provide your feedback and tell SBA what you dislike and like. (Due Aug 5)
